

## Dina DeGeer Co-Lead of Bluewater team announces retirement

Shah will assume primary responsibility for the Bluewater Canadian mandates from Dina. Shah has been with Bluewater for 14 years and has been mentored as Dina's protégé for the past number of years for succession planning. Shah has been a sector generalist, specializing in Canadian equities and a lead researcher and a portfolio manager for Bluewater's Canadian mandates.

David Arpin, Senior Vice-President, Portfolio Manager and Co-Lead, Bluewater, will continue in his role as Strategist and Portfolio Manager across Bluewater strategies. David has 30 years of investment management experience, including 12 years spent working with Dina. David is the lead Portfolio Manager on U.S. and Global Equity mandates. Dina will continue as Portfolio Manager of her funds until August 31, 2024.
